The undersigned law enforcement officer with Fond du Lac County Sheriff's Office being first duly sworn, states that:

**Count 1: FIRST DEGREE RECKLESSLY ENDANGERING SAFETY, REPEATER**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, did recklessly endanger the safety of Victim 1, under circumstances which show utter disregard for human life, contrary to sec. 941.30(1), 939.50(3)(f), 939.62(1)(b) Wis. Stats., a Class F Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of Felony Vehicle Operator Flee/Elude Officer pursuant to Wis. Stat. 346.04(3) on or about October 17, 2023 in Ozaukee County Case No. 2023CF00271, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased by not more than 2 years if the prior convictions were for misdemeanors and by not more than 4 years if the prior conviction was for a felony.

**Count 2: FELONY BAIL JUMPING, REPEATER**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, having been charged with a felony and having been released from custody under Chapter 969 Wis. The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, while operating a motor vehicle on a highway, after having received a visual or audible signal from a traffic officer, federal law enforcement officer, or marked or unmarked police vehicle that the operator knew or reasonably should have known was being operated by a law enforcement officer, did knowingly flee or attempt to elude a traffic officer by willful disregard of the visual or audible signal so as to endanger other vehicles, contrary to sec. 346.04(3), 939.50(3)(h), 939.62(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of Felony Vehicle Operator Flee/Elude Officer pursuant to Wis. The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, as a person having one or more prior convictions, suspensions, or revocations, as counted under s. 343.307 (1) since January 1, 1989, did cause injury to Victim 1 by the operation of a vehicle while under the influence of an intoxicant, contrary to s. 346.65(3p) and, contrary to sec. 346.63(2)(a)1, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(e), upon conviction, the department shall revoke the defendant's operating privilege for not less than one (1) year nor more than two (2) years. In addition, the defendant will be required to undertake an alcohol and drug abuse assessment, and follow through with treatment recommendations as a condition of reinstatement.

**Count 19: OPERATING WHILE INTOXICATED CAUSING INJURY - 2ND AND SUBSEQUENT OFFENSE**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, as a person having one or more prior convictions, suspensions, or revocations, as counted under s. 343.307 (1) since January 1, 1989, did cause injury to Victim 3 by the operation of a vehicle while under the influence of an intoxicant, contrary to s. 346.65(3p) and, contrary to sec. 346.63(2)(a)1, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(e), upon conviction, the department shall revoke the defendant's operating privilege for not less than one (1) year nor more than two (2) years. In addition, the defendant will be required to undertake an alcohol and drug abuse assessment, and follow through with treatment recommendations as a condition of reinstatement.

**Count 20: OPERATING WHILE INTOXICATED CAUSING INJURY - 2ND AND SUBSEQUENT OFFENSE**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, as a person having one or more prior convictions, suspensions, or revocations, as counted under s. 343.307 (1) since January 1, 1989, did cause injury to Victim 4 by the operation of a vehicle while under the influence of an intoxicant, contrary to s. 346.65(3p) and, contrary to sec. 346.63(2)(a)1, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(e), upon conviction, the department shall revoke the defendant's operating privilege for not less than one (1) year nor more than two (2) years. In addition, the defendant will be required to undertake an alcohol and drug abuse assessment, and follow through with treatment recommendations as a condition of reinstatement.

**Count 21: OPERATING WHILE INTOXICATED CAUSING INJURY - 2ND AND SUBSEQUENT OFFENSE**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, as a person having one or more prior convictions, suspensions, or revocations, as counted under s. 343.307 (1) since January 1, 1989, did cause injury to Victim 5 by the operation of a vehicle while under the influence of an intoxicant, contrary to s. 346.65(3p) and, contrary to sec. 346.63(2)(a)1, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(e), upon conviction, the department shall revoke the defendant's operating privilege for not less than one (1) year nor more than two (2) years. In addition, the defendant will be required to undertake an alcohol and drug abuse assessment, and follow through with treatment recommendations as a condition of reinstatement.

**Count 22: OPERATING WHILE INTOXICATED CAUSING INJURY - 2ND AND SUBSEQUENT OFFENSE**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, as a person having one or more prior convictions, suspensions, or revocations, as counted under s. 343.307 (1) since January 1, 1989, did cause injury to Victim 6 by the operation of a vehicle while under the influence of an intoxicant, contrary to s. 346.65(3p) and, contrary to sec. 346.63(2)(a)1, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(e), upon conviction, the department shall revoke the defendant's operating privilege for not less than one (1) year nor more than two (2) years. In addition, the defendant will be required to undertake an alcohol and drug abuse assessment, and follow through with treatment recommendations as a condition of reinstatement.

**Count 23: POSSESSION OF TETRAHYDROCANNABINOLS (THC), REPEATER**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, did knowingly possess a controlled substance, tetrahydrocannabinols (THC), contrary to sec. 961.41(3g)(e), 939.62(1)(a) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned for not more than six (6) months, or both.

And further, invoking the provisions of sec. 939.62(1)(a) Wis. Stats., because the defendant is a repeater, having been convicted of Felony Vehicle Operator Flee/Elude Officer pursuant to Wis. Stat. 346.04(3) on or about October 17, 2023 in Ozaukee County Case No. 2023CF00271, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased to not more than 2 years.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 24: POSSESSION OF DRUG PARAPHERNALIA, REPEATER**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, did knowingly possess drug paraphernalia with the primary intent to use a controlled substance, contrary to sec. 961.573(1), 939.62(1)(a) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than Five Hundred Dollars (\$500), or imprisoned for not more than thirty (30) days, or both.

And further, invoking the provisions of sec. 939.62(1)(a) Wis. Stats., because the defendant is a repeater, having been convicted of Felony Vehicle Operator Flee/Elude Officer pursuant to Wis. Stat. 346.04(3) on or about October 17, 2023 in Ozaukee County Case No. 2023CF00271, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased to not more than 2 years.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 25: OPERATE MOTOR VEHICLE WHILE REVOKED**

The above-named defendant on or about Friday, May 30, 2025, in the City of Fond du Lac, Fond du Lac County, Wisconsin, while being a person whose operating privileges had been revoked pursuant to the Laws of the State of Wisconsin did operate a motor vehicle on a highway during such revocation or thereafter, and the revocation resulted from an offense that may be counted under s. 343.307(2) Wis. Stats., contrary to sec. 343.44(1)(b), 343.44(2)(ar)2 Wis. Stats., a Misdemeanor, and upon conviction shall be fined not more than \$2,500 or imprisoned for not more than one year in the county jail or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.30(1g)(a), upon conviction, the court may suspend the defendant's operating privilege not more than six (6) months.

**PROBABLE CAUSE:**

Complainant bases the allegations of this complaint upon the report and investigation of deputies Joshua Burg, Logan Will, Nolan Hlinak, Evan Hanrahan, and Devin Simon of the Fond du Lac County Sheriff's Office. Complainant and the officer(s) are reliable as sworn law enforcement officials.

On Friday May 30, 2025 at approximately 6:37 p.m. Deputy Burg was traveling southbound on Main St in the City and County of Fond du Lac, Wisconsin. Deputy Burg observed a white SUV, later identified with license plate of ANM-8254 and sole occupant and driver to be the defendant Kaitlynn G. Ray, traveling northbound on Main

St at high rate of speed. Deputy Burg used his radar unit and observed the vehicle to be traveling 53 mph in a 30 mph speed zone as it traveled past his squad car. Deputy Burg was operating in a marked Fond du Lac County Sheriff's Office squad vehicle equipped with emergency lights affixed to the top of the squad car and sirens. Deputy Burg activated his emergency lights and sirens and performed a turned around to pursue the white SUV.

As Deputy Burg was attempting to catch up to the vehicle he observed it increasing speed and driving into the oncoming southbound lane of traffic to pass northbound vehicles. Deputy Burg believed the defendant was driving recklessly with no regard for the safety of other vehicles and people in the area. Deputy Burg observed Ray's to be traveling in excess of 80 mph and showing no signs of obeying his emergency lights and sirens. Deputy Burg noted the time of day on Main St had a lot of pedestrian traffic because of it being a downtown business area. Ray was endangering the safety of the pedestrians and vehicles on the roadway with her driving behavior.

Deputy Burg continued following Ray and her vehicle with his emergency lights and sirens in an effort to warn other of the danger. Deputy Burg observed the vehicle approaching the intersection of Main St. and Division and St and Ray struck an occupied southbound vehicle. After striking the southbound SUV it caught fire and Ray kept driving. Ray then collided with another northbound vehicle, causing that vehicle to spin out of control and airbags to deploy. It was determined that that this vehicle had four juvenile females inside that all suffered injuries.

Ray continued to driving striking multiple additional parked vehicles on Main St, including a sedan occupied by two people. Ray's vehicle eventually stopped while on Main St and caught on fire. Deputy Burg caught up to Ray's vehicle, exited his squad and drew his firearm while commanding Ray to exit her vehicle. Deputy Burg identified the driver of the white SUV that was eluding him as the defendant, Kaitlyn G. Ray.

Ray complied with Deputy Burg's commands and was placed under arrest. As Deputy Burg was searching the defendant he noticed Ray's vehicle begin to start on fire. Deputy Burg then moved Ray away from the vehicle and observed her to have slow and slurred speech with droopy eyelids. Ray complained of an arm injury was later transported to St. Agnes Hospital to be evaluated.

While at the hospital Ray stated that someone was trying to kill her but would not provide any details as to who. Ray stated her vehicle was soaked in gasoline and Deputy Burg noted that she appeared to be hallucinating. Deputy Burg began to suspect Ray was operating under the influence of an intoxicant or drug but did not administer standard field sobriety testing because of the crash. Deputy Burg obtained a search warrant and obtained a sample of Ray's blood to be sent to testing.

Deputy Burg was aware that during a search of Ray's vehicle suspected marijuana was located in a bag that had a 100 bill design on it. The suspected marijuana field tested positive for THC and weighed 6.38 grams

Sergeant Logan Will responded to the scene and assisted with numerous ambulances being deployed to the scene and observed at least six vehicles were struck by Ray's driving and that at least five individuals required medical attention.

Deputy Hanrahan arrived to the scene on Main St and observed a black SUV smoking and made contact with Victim 1. She observed Ray traveling in her southbound lane of travel towards her and had enough tie to slow down but not get out of the way and was hit by Ray's vehicle.

Deputy Hanrahan spoke with Joshua Kattestad, who had been driving ahead of Victim 1 and observed Ray's vehicle strike Victim 1's vehicle and then strike three other vehicles. He stated that Victim 1's vehicle moved approximately 50 feet after being struck by the defendant. Kattestad then attempted to help get Victim 1 out of her vehicle because he observed it starting on fire. Deputy Hanrahan spoke with Victim 1 and learned she was had pain in her neck, her entire left side, and her foot.

Deputy Hanrahan spoke with Victim 2 and learned she was at the intersection of Main St. and Western Ave when the defendant's vehicle passed her at she estimated to be 8-90 mph, if not faster.

Deputy Hanrahan met with Deputy Simon and learned four additional females, all juveniles (Victims 3, 4, 5, and 6), were in a vehicle struck by the defendant and had suffered injuries. Deputy Hanrahan observed one of the girls to have bruising on her legs, the second girl had cuts on her left and right knees and a scrape on her back. The third girl had scrape marks and bruising on her right arm. The fourth girl did not have any visible marks but was observed to be walking with a limp.



Deputy Hlinak assisted with the scene and observed at least 100 people on the sidewalks appearing shocked at what they were observing. Deputy Hlinak observed the defendant's SUV was facing north in the northbound lane and had significant front end damage with an orange light emanating from the under the hood. This led him to believe the vehicle was on fire and he retrieved a fire extinguisher from his squad car and when he returned to Ray's SUV he observed an active flame under the hood and used his fire extinguisher to put out the fire.

Deputy Hlinak then began to document the scene with photos, taken 163 photos.

Deputy Hilnak observed a Kia parked in front of 36 N. Main St. with driver side damage and a rear driver side tire deflated, with a white paint transfer on the driver's side front door extending to the area of the trunk.

Deputy Hilnak observed a Buick parked in front of 59 N. Main St. with significant rear end damage that caused the trunk to remain in the open position.

Deputy Hilnak observed a Toyota parked in front of 39 N. Main St. with rearend damage from the incident caused by another vehicle being pushed into. That vehicle was a Honda with significant damage. It appeared to have been struck with such force that it rotated 90 degrees and was wedged between two vehicles.

Deputy Hilnak observed another Honda parked in front of 37 N. Main St. with significant damage from the incident. The front passenger tire was deflated and the majority of the damage was on the driver's side.

Deputy Hilnak observed a Subaru parked in front of 35 N. Main St. with damage from the incident. The front driver-side quarter panel near the headlight appeared to have been ripped out almost entirely from the vehicle. The bumper was "unpositioned" from the crash.

Deputy Hilnak observed a Chevrolet parked in front of 28 N. Main St. with damage from the incident. The vehicle was hit with such force that the wheel closest to the driver was gone.

Deputy Hlinak searched Ray's vehicle and located the suspected marijuana on the floor near the pedals, which had the appearance of a green like substance with a scent of marijuana, which through his training and experience appeared to be THC.

Deputy Simon assisted with the scene and made contact with Chad Dreher, who helped Victim 1 from her vehicle. Deputy Simon observed that where Victim 1's vehicle was that the defendant would have been driving in the wrong lane of traffic when striking Victim 1. Deputy Simon did not observe any preimpact braking from the defendant.

Deputy Simon then made contact with four juvenile females, Victims 3, 4, 5, and 6. All four victims were in the same vehicle struck by the defendant. Victim 4 stated she could hear sirens but didn't see the vehicle hit her vehicle. She heard a loud noise causing the Honda she was in to rotate. Victim 4 stated she had soreness in her left calf and would be going to the hospital to be evaluated.

Deputy Simon spoke with Victim 5 and observed injuries to both her knees with a red mark on her right knee and a band aid on her left knee. She described the pain at this time to be a 3/10.

Deputy Simon spoke with Victim 6 and learned she had pain in both her hips, her lower back. She estimated the pain to be a 5/10.

Deputy Simon spoke with Victim 3 who shared that she had pain in her right arm as a result of the crash, which felt was a 3/10 on a pain scale.

Based on the foregoing, the complainant believes this complaint to be true and correct.
