CRIMINAL COMPLAINT

For Official Use

The undersigned law enforcement officer with Fond du Lac County Sheriff's Office being first duly sworn, states that:

Count 1: SEXUAL ASSAULT OF A STUDENT BY SCHOOL STAFF

The above-named defendant on or about Wednesday, July 30, 2025, in the Town of Marshfield, Fond du Lac County, Wisconsin, did have sexual contact with VICTIM, DOB April 2006, a child who had attained the age of sixteen, and is not the defendant's spouse, said child being enrolled in a school, and said defendant being a member of that school staff, contrary to sec. 948.095(2), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 2: SEXUAL INTERCOURSE WITH A CHILD

The above-named defendant on or about Wednesday, July 30, 2025, in the Town of Marshfield, Fond du Lac County, Wisconsin, did have sexual intercourse with a child, VICTIM, DOB April 2006, who was not her spouse and who had attained the age of 16 years, and the actor had attained the age of 19 years, contrary to sec. 948.09, 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 3: EXPOSING A CHILD TO HARMFUL MATERIAL

The above-named defendant on or about Wednesday, July 30, 2025, in the Town of Marshfield, Fond du Lac County, Wisconsin, with knowledge of the character and content of the material, did distribute harmful material to a child, VICTIM, DOB April 2006, with or without monetary consideration, contrary to sec. 948.11(2)(a), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

PROBABLE CAUSE:

Complainant bases the allegations of this complaint upon the report and investigation of officer(s) Kieran C Weed, of the Fond du Lac County Sheriff's Office. Complainant and the officer(s) are reliable as sworn law enforcement officials.

On Wednesday, July 30, 2025, Deputy Weed responded to the Sheriff's Office for a sexual assault complaint waiting in the lobby. Information was that the complainant was a 17 year old student in 2023 when it occurred, and it occurred at an address in St. Cloud.

VICTIM stated she was the victim and this began occurring in 2023 between her and one of her high school teachers, Marcie Zimmerman. At the time of the incidents VICTIM was a 17 year old junior at Plymouth High School and Marcie was her culinary teacher. It was later discovered some of the sexual activity occurred when VICTIM 16 years old at the time (DOB: April 2006). It was confirmed the sexual activity occurred over cell phones and in person at Marcie's residence which was confirmed at N9516 CTH GG St Cloud, Town of Marshfield, Fond du Lac County, WI.

VICTIM said she got to know Marcie very well and would talk with her about a lot of her personal issues especially mental health struggles she was having. These conversations and the friendship started around January 2023, VICTIM's junior year at Plymouth High School. This turned into VICTIM and Marcie having a close relationship where they would text and talk both at school and outside of school. VICTIM admitted to Deputy Weed the relationship turned sexual over cell phone conversations as well as in person sexual contacts in the months to follow.

WITNESS said around January of 2023, she noticed a change in VICTIM's behavior and they started catching VICTIM lying about where she was sleeping over. VICTIM told WITNESS it was friends' houses but later discovered she was sleeping at Marcie's house. WITNESS provided Deputy Weed a four page report she had typed up documenting her concerns in 2023 that was provided to the Plymouth School District at that time.

This includes, Marcie friending VICTIM on all social media, spending time with VICTIM outside of school, allowing VICTIM to drive Marcie's car, allowing VICTIM to sleep at Marcie's house and ends phone conversations with "I LOVE YOU."

It details how Marcie was manipulating VICTIM and getting VICTIM to lose friends, not listen to her own parents and not trust anyone but Marcie. As both WITNESS and VICTIM used the word, it was Marcie grooming VICTIM. This report was typed June 20, 2023 and turned over to the Plymouth School District. The district met with WITNESS and VICTIM over this matter, but WITNESS told Deputy Weed that Marcie remained employed and later found out that Marcie and VICTIM had created fake social media profiles to remain in contact with each other.

VICTIM did add that since this relationship began with Marcie, she has experienced trauma and stress from the manipulation and grooming from Marcie. VICTIM said every time she tried to end contact with Marcie, she would make suicidal comments or comments about how this would become public knowledge and ruin VICTIM's and Marcie's reputation.

VICTIM told Deputy Weed around March 2023, when she was still 16 years old in her junior year, it turned sexual when Marcie texted her one morning that "she had a dream about VICTIM." VICTIM responded asking Marcie what kind of dream and Marcie said a dream where "VICTIM went down on her." VICTIM explained she understood the context of that as performing oral sex on Marcie. VICTIM admitted to continuing messaging Marcie sexual in nature conversations following that. In the days to follow Marcie sent VICTIM a 30-45 second video of Marcie naked in the bathtub and masturbating or rubbing her vagina. VICTIM said she slept over at Marcie's house a total of five to six times. The first two times they both slept in Marcie's bed fully clothed and nothing sexual occurred. In June 2023, after the school year finished, VICTIM explained she continued having sleep overs at Marcie's house. Around the third time she slept over, Marcie asked VICTIM if she wanted to do sexual things and that it would all be okay if she did. VICTIM responded okay and said she went along with it. VICTIM said they were both naked and Marcie began kissing VICTIM on the lips and neck. VICTIM said at that time she was still a virgin. Marcie began fingering, inserting her fingers into VICTIM's vagina, for approximately one hour. Marcie asked VICTIM to "go down on her" but VICTIM said no. During another sleep over, still in June 2023, they were both naked in Marcie's bed and Marcie began kissing VICTIM all over her body including kissing her exposed breast. Marcie then "went down on" or performed oral sex on VICTIM.

VICTIM told Deputy Weed during that same time frame, June through August of 2023 during summer break, VICTIM and Marcie continued to exchange sexual pictures and videos. VICTIM estimated she sent 20 pictures of her naked breast and vagina to Marcie but didn't believe she sent any videos. Marcie sent VICTIM roughly 30 pictures of her nude breast and vagina as well as videos of her masturbating or pleasuring herself with a strap on or vibrator. VICTIM said the majority of messages were sent via IMESSAGE which is the main texting app on Iphones. VICTIM said they also sent messages through Snapchat. VICTIM's Snapchat username at that time was "VICTIMjones1" and Marcie's was "Zimmy82." VICTIM said they were also friends on Instagram, Facebook,

TikTok and VSCO but didn't use those apps to send sexual material. VICTIM added that Marcie lives with her dad, and he would usually be home and would have no idea what Marcie and VICTIM were doing.

VICTIM said that once her mom went to the school with her report in June 2023 that changed the dynamics of their relationship, but when school started in September of 2023 Marcie would go out of her way to contact VICTIM. Marcie created new social media accounts and got a new phone number to contact VICTIM. Marcie would always have VICTIM saved as a "Nick" in her contact list. VICTIM told Deputy Weed although the school had put a no contact in place so Marcie wouldn't contact VICTIM, Marcie never stopped. Marcie would message VICTIM on social media during the 2023-2024 school year to meet in the bathroom to talk as well as other communication. VICTIM added she worked at St. Vincent De Paul in Plymouth from 2022 until June 2025 and Marcie would come there all the time to shop but mainly just to see VICTIM. VICTIM explained Marcie was controlling and manipulating enough that VICTIM felt she couldn't end contact or get out of the friendship/relationship.

After VICTIM graduated High School in June 2024, VICTIM told Deputy Weed she blocked Marcie's numbers and usernames on all social media apps and told Marcie to never contact her again. VICTIM currently works at Walmart in Plymouth and said twice in July 2025 Marcie has come to Walmart. One occasion Marcie spoke with another co-worker at Walmart who was also a former student at Plymouth High School, and asked that female about VICTIM and what her work schedule was. VICTIM said in July 2025, Marcie was in her car and was following VICTIM around Plymouth until she pulled into Walmart to go to work then Marcie sped off. VICTIM told Deputy Weed she knows it was Marcie as she could see her, and also knows she drives a white Chevy with personalized plates "ZIMMYZ." Also around March 2025, Marcie texted VICTIM's friend "Addie," and told her to tell VICTIM she was leaving the Plymouth School District but it wasn't her fault.

VICTIM admitted she also fears that Marcie still has all the sexually explicit material saved on her phone and that to revenge VICTIM or blackmail her, she will release it to the public at some point. Marcie stored all of the sexual content that VICTIM shared with her on some secret App on her cell phone.

On around August 20, 2025 VICTIM said she had heard from her friends and coworkers that Marcie still has been asking all of them recently about VICTIM.

On Friday, August 22, 2025 VICTIM advised Deputy Weed that Marcie had tried calling her but VICTIM did not answer.

Marcie did not answer the first call but called VICTIM's phone back a few minutes later. Marcie denied saying or talking negatively about VICTIM to her friends. Marcie stated she left Plymouth School District because she couldn't continue living in the silence and everyone was always asking her about VICTIM and what happened between them.

VICTIM continued asking Marcie what she told people, if she told people about their intimate relationship and if it was going to become public knowledge and Marcie said she never told a person and kept that all to herself. VICTIM asked Marcie if the content she had sent her, meaning sexual videos/pictures, were still on Marcie's phone and Marcie replied no, I deleted everything and no one would ever find it.

VICTIM also provided a detailed description of Marcie's room and house, which was actually Marcie's father's house located at N9516 CTH GG, St Cloud, WI. VICTIM sketched the floor plan of the house as well as Marcie's bedroom. VICTIM described Marcie's bedroom as having hats on the wall, Dock Spiders and another Fondy team.

Conversation with Marcie on August 25, 2025:

Marcie ZIMMERMAN said everything with VICTIM began when VICTIM was in her Culinary Two class, and Food Science class. Marcie ZIMMERMAN said VICTIM started reaching out to her, and got comfortable with her. She said VICTIM started reaching out to her after school using Facebook Messenger. VICTIM confided in Marcie ZIMMERMAN about issues she was having at home, and in her life in general. Marcie ZIMMERMAN said she would respond to VICTIM' messaging.

Marcie ZIMMERMAN said that VICTIM ended up spending the night at her residence, N9516 County Highway GG. That would've been the night of Prom. After the sleep-over, VICTIM and Marcie ZIMMERMAN developed a

"major closeness". Their messaging frequency increased, and Marcie ZIMMERMAN acknowledged that she would respond whenever VICTIM messaged her.

Marcie ZIMMERMAN said VICTIM stayed with her at the Day's Inn because VICTIM wasn't feeling safe at home. So for that reason she got them a room at the hotel. They stayed together in the hotel overnight, and then the next morning VICTIM went home.

Detective Tikkanen asked her if she and VICTIM had a sexual relationship, her response was "she came on to me." Marcie ZIMMERMAN went on to explain that VICTIM wouldn't leave her alone, and her communication was just constant. Marcie ZIMMERMAN said things escalated to the height of their relationship due to VICTIM and her frequent messaging.

Deputy Tikkanen moved on and asked Marcie ZIMMERMAN how many times was there sexual contact, or touching that occurred between her and VICTIM. Marcie ZIMMERMAN said not many, she said less than ten and it was closer to five times.

Based on the foregoing, the complainant believes this complaint to be true and correct.
